THROUGH THE CAMPAIGN, MLI RAISES PRIVATE FUNDING TO PROVIDE HIGHLY TRAINED DOGS TO "SNIFF OUT" LANDMINES AND OTHER EXPLOSIVES TO SAVE AND IMPROVE LIVES IN SEVERELY CONTAMINATED, WAR-TORN COUNTRIES.
